Frequently Asked Questions

What if a mistake is made entering the certificate holder information?

You can generate a new COI with the correct certificate holder information. Follow the same steps outlined above.

How long will the COI display within the portal?

At this time all generated certificates will appear within the Certificate of Insurance tab, regardless of when they were created.

Why is my Certificate not displaying?

Certificates of Insurance generated by Agents will not appear in online accounts.

Only certificates generated for policies listed within the user's profile will appear in online accounts. If a policy was removed from the user profile, the previously generated certificate will be removed.

Can I delete a COI from my profile?

At this time, all generated certificates will remain in the Certificate of Insurance tab and cannot be deleted.

My certificate holder is requiring additional language on the certificate, how do I add this?

Any requests that require additional language will need to be completed by your independent agent or broker.
